INTRODUCTION

INTRODUCTION TO THE NRF

The National Research Foundation Act as amended, Act 19 of 2018, establishes the National Research Foundation (“NRF”) as the juristic legal entity that will contract with the awarded bidder. Please visit the NRF website (<https://www.nrf.ac.za>) for more information.

BACKGROUND TO SARAO

The South African Radio Astronomy Observatory (SARAO) is the National Research Foundation’s National Facility incorporating South Africa’s radio astronomy instruments and programmes such as the MeerKAT and KAT-7 telescopes in the Karoo in the Northern Cape, the Hartebeesthoek Radio Astronomy Observatory (HartRAO) in Gauteng, the African Very Long Baseline Interferometry (AVN) programme in nine African countries as well as the associated human capital development and commercialisation endeavours. THE REQUIREMENTS OF THIS BID

In the course of its business, SARAO often requires photography and videography services, including virtual reality, time lapse, 360° footage and drone imagery. SARAO celebrates a number of project milestones, special events and dialogues that need to be documented, broadcasted, published and captured. Through this bid, SARAO intends to appoint a panel of at least four professional photographers and videographers to provide the aforementioned services. Work will be allocated on a rotational basis, as and when required.

PRE-EVALUATION ELIGIBILITY CRITERIA

PART A–BID REQUIREMENTS

SERVICE SPECIFICATIONS

SARAO intends to appoint a panel of service providers for a period of 3 years for Photography, Videography, Time lapse, Virtual Reality / 360-degree and drone footage. Once awarded, the tender will work on a rotational basis whenever the required need arises.

Specifications can be found below:

1. Photography

Photography will range from portrait images of individuals to industrial photographs of various technologies / items / products through to 180- degree semi-hemispheric/ images for digital planetariums and 360-degree panoramic images, as well as panoramas. Photographs will need to be done using the most recent, innovative and creative photography techniques in order to present the various products, stages of construction, and business of the SARAO in a captivating manner. These images should be able to reflect the world-class research and facility that is true for SARAO.

Photographs should be presented in TIFF and RAW format for large graphic printing, as well as JPEG or PNG that will allow for web-based publishing, with the option for inclusion in all print and broadcast spheres (television/digital video/analogue, etc.). These images need to contain IPTC information.

The candidate service providers will need to show evidence, by presenting a portfolio of their ability and experience in using various techniques in order to capture images on film and how/ where these were used. The bidder's footage and photos must be submitted in Low and high resolutions (of various requirements) will need to be made available of each image in order to facilitate the sharing of this information.

2. Video footage

The business of SARAO requires that we often have to share information and conduct dialogue sessions that link our offices across our three sites and our partner organisations from across the globe. For this reason, for special events / strategic dialogue sessions, etc., we are required to provide high quality video images that allow for the optimal level of engagement through these internet-based meetings.

Outside of this specific technical requirement, we will also require the filming of key events, public talks, et cetera, on video in the formats and of the quality that would allow for broadcast on various platforms (online, digital, analogue, television, etc.). Low and 4K resolutions /definition video footage (of various requirements) will need to be made available of each recording in order to facilitate the sharing of this information.

On completion of the capturing of the video footage, an AV production of between 3-5 minutes needs to be provided, when requested.

3. Virtual Reality/360 Degree

The successful service provider needs to ensure that virtual reality videography is captured, and post production completed and needs to be submitted in a format which is ready for display and can be viewed using a google box or VR headset/ Oculus Rift sets.

4. Time Lapse Images

The successful bidder will be required to capture time lapse images of our site in Carnarvon in the Northern Cape, as well as any further construction or for the purpose of updating stock.

5. Drone

The successful bidder must have capacity do drone footages using RFI drone equipment.

National representation

SARAO requires that the candidate service provider demonstrates their ability to provide the service of delivering on the required products by having a technical crew available in both the Western Cape and Gauteng Provinces. If the candidate service provider will be demonstrating this through a process of subcontracting, then a detailed list of all intended sub-contracting companies or individuals will need to be included in the proposal.

It is essential SARAO that the products are not reflective of a single artistic approach or technique but uses a variety of techniques in order to deliver on the required products.

It is therefore essential that the candidate service provider demonstrates their ability to include a number of skilled and artistic professionals on their team. The candidate service provider will be required to demonstrate this by including a portfolio of their team members with a brief profile of each.

It may be required that the actual products are used to portray the information required. It is therefore essential that the candidate service provider demonstrates their ability to communicate key messages, provide a narrative through the delivery of the required products. This can be done by including a specific focus in the portfolio that demonstrates 'journalist photography', 'exhibit photography', etc.

Cataloguing, filing and submission

All products need to be submitted to SARAO in digital format. All the relevant images need to be completed with the necessary IPTC metadata, and sent in a version which is archived. The associated courier costs / data download costs will be covered by SARAO. All data upload costs will need to be covered by the successful bidder.

Within 36 hours following the conclusion of a commissioned assignment, the successful bidder needs to provide access to the required products. These products will need to be filed appropriately and each product labelled with a caption that includes the necessary information. All products and processed images must include the following metadata in the XMP format (header and structure will be provided by the SARAO):

- Location where product was captured – by way of GPS coordinates;
- Names of all individuals included in the images / captured on film – full names and titles;
- Names of instruments, objects that are captured;
- Name of Location where the image was taken;
- Name of event;
- List of instruments in the image / capture on video;

- Name of objects in the image;
- Full names and titles of individuals captured in the image/ on video;
- Photographer Name;
- Photographer email address.

Travel and Logistics

Given the requirement that the successful bidder will need representation in the Western Cape and Gauteng Provinces, no travel costs for assignments commissioned in these provinces will be covered by SARAO.

SARAO will however, cover the associated costs of traveling a team of no more than three persons to a specific venue outside of these provinces when commissioning an assignment. SARAO will therefore be covering the travel related costs i.e. flights, excess baggage, car hire, petrol allowance and accommodation of visits to the site in Carnarvon for no more than three persons upon discussing the assignment costs associated with the commissioned work.

Travel and accommodation arranged by SARAO will be aligned to the standard operating procedures and policies that SARAO is required to abide by as a business unit of the National Research Foundation.

IMPORTANT INFORMATION FOR BIDDERS TO NOTE

Bidders must note that with regard to the Schedule of Equipment to be submitted, the following conditions will apply-

1. Bidders must provide SARAO with a list stating the brand name and type - of all cameras and other electronic equipment that will be used for the execution of this tender. This can be handed in at the Non-compulsory briefing session or can send list through email to Mr Angus Flowers aflowers@ska.ac.za. Bidders will have until 18 October 2019 to have any equipment RFI tested at the SARAO offices in Observatory, Cape Town.
2. SARAO will investigate the list and indicate to the bidder the following:
 - (a) Equipment that SARAO has tested and that presents a high RFI risk -
 - (i) these items cannot be included in the tender or be used on site and the tenderer will need to find an alternative.
 - (b) Equipment that SARAO has tested and does not present a high risk -
 - (i) these items can be included in the tender, once the tender selection has been done and a service provider appointed, RFI permits will be issued for these items.
 - (ii) The RFI permits will have restrictions on where and when the equipment can be used.
 - (iii) If these restrictions prevent the service provider from executing his duties as per the contract, then special arrangements may be negotiated at the discretion of SARAO.
 - (c) Equipment that SARAO has not yet tested –
 - (i) Bidders will be requested to present these items to SARAO for testing in our in-house facility by the

18 October 2019.

Once such a test has been done it will be handled in terms of paragraph (a) and (b)

DOCUMENT PACK EVIDENCING EXECUTION OF CONTRACT

1The bidders must provide the following documentary evidence demonstrating ability to execute this contract: Proposals must include:

- 1.1. A comprehensive portfolio of projects relevant to the scope of works, which evidences range and calibre of projects completed, and at least 2 years' professional experience. A detailed submission of the aforementioned can be in the form of CDs, USB or downloadable link that demonstrates the bidder's project portfolios covering photography, videography, time lapse and virtual reality videography. This will include drone footage as well as 360° footages.
- 1.2. A schedule of equipment in response to the specification in this invitation for Radio Frequency Interference (RFI) testing purposes.
- 1.3. Evidence of capacity and capability to execute the contract.

Three (3) written references with contact details per relationship type where applicable, for those customers for whom the bidder has completed work within the last sixty months.

CONTRACT PERIOD

The contractual period for this bid is three years. Commencement will be date of final signature on the SBD 7 Contract Signing Form.

CONTRACT MANAGEMENT

1 Contract managers

- 1.1 SARAO will provide the contract manager details to the appointed third party
- 1.2 The appointed bidder provides the name and contact details of their contract manager upon signing the contract to the SARAO contract manager.
- 1.3 Where either party changes the contract manager, they must advise the other party within 5 working days.
- 1.4 The appointed bidder at all times receives instructions from the SARAO contract manager.

2 Contract management meetings

- 2.1 A meeting between the appointed bidder and the SARAO contract project manager shall take place within one week of signing the contract to confirm the final agreed specification, validate the methodology method being applied during the contract period.
- 2.2 SARAO will issue purchase orders as and when the service is required.
- 2.3 The appointed bidder and/or the SARAO contract manager will arrange additional contract meeting where operational issues require such meetings outside of the agreed scheduled meetings.

3 Verification of deliverables after contract (SBD 7) is signed

3.1 The SARAO contract manager verifies the performance of this contract with reference to the required deliverable inclusive of the following:

- 3.1.1 The work will be rotated as per each bidder's ranking outcome on BBBEE and pricing evaluation.
- 3.1.2 The first preference will be given to the bidder with the highest ranking.
- 3.1.3 The bidder will be contacted to provide quotation for each job to be executed
- 3.1.4 The bidder will have exported to respond on SARAO request with 12 hours if not, the highest ranked bidder will be approached to quote.

4 Communication

4.1 The contracted parties communicate in writing through mail, delivery, or email. The contracted party states the contract number and purchase order number, if the latter is applicable, on communication documentation. The contract party does not act upon any communication without the contract number or must verify such communication with the assigned NRF contract manager prior to acting upon it. Support service

5 Subcontracting

5.1 Any sub-contract to another party complies with the requirements of the Preferential Procurement Policy Framework Act and its regulations.

6 Insurance

6.1 The contractor carries insurance of at least R 3 million for both: public liability (including product liability) and professional indemnity. NRF assets in custody of the contractor are insured for the value of the replacement value of the asset.

7 Payment

7.1 Payment terms are as less than 30 days from date of receipt of invoice. Qualifying invoices for payment must meet the following minimum requirements:

- 7.1.1 Reference to purchase order number
- 7.1.2 Detailed Line items as specified in purchase order
- 7.1.3 Reference to approved Certificate of Conformance

7.2 Prerequisite is approval for payment made by the SARAO contract manager, on the basis of the SARAO contract manager verifying all verification documents. The invoice is accompanied by SARAO agreed signed proof of performance/delivery stating acceptance of quantity, acceptance to specification, and unit pricing in agreement with the contract and any purchase orders issued in terms of the contract.

8 Termination of contract due to non-performance

8.1 In the event of the non-performance as per the agreed contract, SARAO will appoint an alternative at the cost of the appointed third party. The defaulting third party is obliged to settle the damages/additional costs that SARAO has incurred as result of the non-performance of the appointed bidder.

9 Occupational Health and Safety when working on NRF sites:

9.1 All personnel performing work on SARAO sites as part of this contract are responsible to obtain safety induction.

9.2 Over and above the obligations provided by the Occupational Health and Safety Act (OHS Act No 85 of 1993 and its Regulations, known as 'the Act'), the appointed bidder meets with all relevant health and safety instructions as given to them by site safety personnel, where relevant. Personal protection equipment including closed safety shoes, hard hats, height safety equipment, and high visibility vests are worn at all

times while on the work site. All personnel are to obey the relevant instructions, including signage, related to restricted access and speed limits on all sites.

- 9.3 The appointed bidders, once signing the contract (SBD 7), is responsible for itself, its employees, and those people affected by its operations in terms of the Act the regulations promulgated in terms thereof. The appointed bidder performs all work and uses equipment on site complying with the provisions of the Act.
- 9.4 To this end, the appointed bidders shall make available to NRF Corporate on the valid Letter of Good Standing in terms of the COID Act and ensures its validity does not expire while executing this bid, where applicable. The appointed bidders furnishes its registration number with the office of the Compensation Commissioner.
- 9.5 The appointed bidders maintain a health and safety plan complying with the requirements of The Act at the work site during the period that contracted work takes place on the site.
- 9.6 SARAO manages the appointed bidder in his capacity for the execution of this contract to meet the provisions of the said Act and the regulations promulgated in terms thereof. The appointed bidder accepts liability for any contraventions to the Act. Each member of the appointed bidder's team (including sub-contracted personnel), submit a signed indemnity form prior to entering the work site and kept in the appointed bidder's health and safety file.

10 Original bid documents for contract signing

- 10.1 The sets of original bid documents in hard copy format (paper document) serves as the original master set for the legal contract document between the contracting parties. The master set remains at the NRF and has precedence over any other copies in the case of any discrepancies within the other sets of documents. The master set has the originals or certified copies of any certificates stipulated in this document attached.

11 Managing service levels

- 11.1 Upon appointment, both parties agree on the final set of performance levels for each deliverable service levels including measurable key performance indicators with minimum thresholds in writing which is appended to this contract document.
- 11.2 Where both parties agree to variation of these, both parties sign the revision which is appended to this contract document.
- 11.3 The appointed third party and the SARAO contract manager measure delivered performance against these performance levels.
- 11.4 Where either party has identified poor performance under this contract, both parties will meet and investigate the matter to determine the root cause, the correction plan, and the execution planning thereof.
- 11.5 Both parties will monitor the corrective actions.
- 11.6 Both parties will assess the applicability of penalties to the incurred poor performance and apply these,
- 11.7 The service performance levels are:

GENERAL AND SPECIAL CONDITIONS OF CONTRACT

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words "department" means organs of state inclusive of public entities and vice versa, and the words "will/should" mean "must".

The National Research Foundation cannot amend the National Treasury's General Conditions of Contract (GCC). The National Research Foundation compiles separate Special Conditions of Contract (SCC) relevant to this bid where applicable supplementing the General Conditions of Contract. Where there is conflict, the provisions of the Special Conditions of Contract shall prevail.

GCC 1	Definitions - The following terms shall be interpreted as indicated:
1.1	"Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
1.2	"Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
1.3	"Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
1.4	"Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
1.5	"Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
1.6	"Country of origin" means the place where the goods were mined, grown, or produced, or from which the services are supplied.
